#### How to get ahead in libraries webinar part two, 5 February

Interested in a library leadership role but don't fit the traditional profile? The second 'How to Get Ahead in Libraries' webinar may be of interest. It will focus on the routes into leadership without a formal library qualification, often seen as a barrier to more senior leadership. All of our speakers here have explored alternative routes to 'library school' and are now in a variety of senior roles. Speakers Chris Banks (Imperial College London), Dr Sarah Pittaway SFHEA (Birmingham City University) and Simon Hall (Head of Library Liaison (Medicine and NHS) will share their journeys and give practical suggestions for others looking to take that same step. #### Walking away: what happens next? webinar, 7 March

With negotiations with five of the largest academic publishers coming up in 2025 and continuing concern about the value for money and ethics of the "big deals", many SCONUL member institutions will be considering their options and strategic approach. If the publishers do not recognise the need for reform and the challenging financial situation facing UK HE, many institutions will of course consider walking away. What happens within an institution in the run-up to making this decision, and what happens next? This webinar will explore these questions. We are joined by speakers from three institutions which have taken this step and who are willing to share their experiences and to take questions. #### Briefing paper on the development of rights retention policies in the UK

SCONUL has published and update on the current position on the development of rights retention policies in the UK. This shows that around 60% of institutions either have a policy in place or one in development. For institutions in Jisc bands 1-5b, 71% of institutions already have one in place or expect to in this academic year. The briefing paper also includes a useful case study from Brunel University highlighting savings of £47k as a result of having a RRP policy in place. #### **Open Book Collective Development Fund 2025**

The Open Book Collective has launched its second call for applications for funding from their Collective Development Fund. This fund is to support: 1) Creating and supporting infrastructures and/or workflows for the distribution, cataloguing and/or preservation of Open Access scholarly books; 2) Building and sustaining networks and advocacy for the support of OA scholarly books and infrastructure; and 3) Projects building capacity for scholarly OA book publishing. In this 2025 round, they expect to award at least one grant of up to £15,000 and two to five grants of up to £7,500 for projects with a duration of up to 1 yearAll versions can be accessed from this link. This round of applications will close on March 17 2025.

#### Behind the scenes at SCONUL

This month SCONUL has been working with colleagues at Jisc on **preparations for this year's set of "big deal" journal negotiations**, including looking at the sector's readiness and capacity for walking away. Our work on rights retention mentioned above is one output of this, but we are also looking at access to ILL providers.

We have been in discussion with partners and allies around the appetite and opportunities for **closer collaboration and shared services between libraries**, following the <u>recent KPMG report</u>. SCONUL is organising a facilitated round table for sector leaders to identify opportunities the outputs of which will be shared with the community.

We have also been hosting a **symposium for national and regional library consortia** to discuss our shared agendas, particularly around the scope for greater collaboration and shared services across the sector, and on our common mission to advocate for the value of libraries and their contribution to their institutions' missions.
