# SCOPE 3 emissions requirements webinar, 3 May 2pm

SCONUL are bringing colleagues together to explore what the drive to reduce SCOPE 3 emissions means for institutions and how we can work with our supply chain, our spaces and our people to drive the change we all need to see. Led by the SCONUL project team on sustainability and the climate crisis, this webinar to provide an opportunity for those leading libraries to consider the implications of SCOPE 3 emissions requirements; to hear how colleagues in other libraries and sectors are approaching these challenges and to consider what actions we can take collectively to make change. #### **Controlled Digital Lending webinar, 8 May**

This briefing, due to published this month, outlines the legal case for academic libraries to make use of CDL under UK law. We

The report is a comprehensive piece of work, that goes into great depth on the enduring impact of these deals on the UK and global scholarly communications landscape. Jisc recognises that providing full details of metadata sources is time-consuming and may not be possible for all. Submitting any level of detail will be useful so do consider contributing to the spreadsheet even if you aren't able to provide full details. # Jisc's new purchasing system helps organisations buy digital preservation solutions.

Jisc has launched the digital preservation (DP) dynamic purchasing system (DPS) which offers a simple mechanism to encourage the take-up of digital preservation solutions. Based on sector requirements for data management, this new system will enable Jisc members to procure digital preservation tools through a fast, compliant, and competitive process. As a compliant process it also means reduced procurement risk. The digital preservation DPS will run for an initial three years to 3 March 2027 with the possibility of extending for a further year to 3 March 2028 and then to 2029. #### Jisc licensing banding review

Jisc are in the process of a banding review. Jisc bands are used to determine your subscription fee for the negotiation and licensing service. Any changes to your band as a result of this review will not come into effect until August 2025. Once complete, Jisc will consult on a proposal with their strategic member groups. An agreed implementation plan will be shared with members by September 2024. To minimise fluctuations for those affected, Jisc will aim to phase in price changes to relevant negotiations. Please note that any changes will only affect renewals and will not apply to any agreements already signed up to. Jisc last updated the higher education (HE) banding scheme in 2017, and subsequently delayed due to the COVID-19 pandemic. A book contract has been signed with the American Library Association. They are seeking broad and deep topics and perspectives from library leaders with varied experiences, backgrounds, and leadership practices such as: lived experiences on equity, diversity, and inclusion; social justice leading; critical leadership practices or knowledges as BIPOC, women, or other marginalized identities within homogenous and male-dominated academic structural antagonisms; theorizing leadership in research, teaching, or practice through systemic or epistemic injustices lens; plurality of perspectives from personal, institutional, or professional experiences on leadership/administrative experience or sustenance.
