### Shared services

Universities UK has published a report from its Transformation and Efficiency Taskforce looking at the scope for further shared services and collaboration between HEIs in the UK which is available here: *Transformation and Efficiency-Towards a new era of collaboration*. The taskforce [has identified seven opportunities to drive transformational change](#) and references Falmouth Exter Plus as an example of innovative collaborative structure which includes a shared library service. It identifies a set of actions for sector bodies and government and SCONUL will be meeting stakeholders including Jisc and UCISA shortly to discuss these further. Later this month, SCONUL will be publishing the outputs of its own shared services roundtable which will explore the libraries' view of the opportunities in this space.

### **Scottish Universities Press unveils new open access textbook programme for 2025**

Scottish Universities Press (SUP) has launched an open access textbook programme which commenced in May 2025. This development builds on the success of SUP's open access monograph and edited collection publishing that launched in 2024. SUP are seeking to address the significant need for more affordable and accessible educational resources across the UK higher education landscape. SUP is a library-led initiative, organised by SCURL and operates collaboratively by member libraries on a not-for-profit basis. It is dedicated to advancing open access publishing, making high-quality scholarly research and educational resources available to a global audience without barriers to knowledge, and increasing the impact of academic work. ### **IReL Principles for Negotiations**

The Irish Research e-Library (IReL) has published its new [IReL Principles for Negotiations](#). In light of evolving policy and emerging international consensus, the IReL Advisory Committee has reviewed and redrafted IReL's principles. This process has been informed not only by international discussions but also by feedback from stakeholders and the hands-on experience of the IReL Negotiation Group, who is charged with ensuring that such principles are implemented. These renewed principles will inform IReL negotiations from 2025 onwards and help to guide the IReL Negotiations Group in deciding on where best to invest existing and finite funds. [Read more](#)

### **Launch of the Beta version of the new English Short Title Catalogue (ESTC)**

The Beta version of the new English Short Title Catalogue (ESTC), the most comprehensive resource available for the output of the printing press in the English-speaking world before 1801, has been launched. ESTC is now part of the Consortium of European Research Libraries' (CERL) ecosystem and accessible for free at <https://datb.cerl.org/estc/>. For the first time since October 2023, ESTC is fully accessible again. This Beta version provides basic and advanced search facilities with further features, including browsing, facets and an editing interface for contributors, to be deployed later this year. ### **CILIP launches £1.2 Million Green Library Hubs project**

CILIP has launched the Green Library Hubs programme. The three-year programme, delivered in partnership with the British Library, Julie's Bicycle and CAG Consultants, along with 10 libraries across the UK, will establish 10 Green Library Hubs – spaces rooted in local libraries that act as catalysts for community awareness, behaviour change and grassroots action on climate change. The project is an integral part of the [Green Libraries Campaign](#), of which SCONUL is a partner, and activities delivered through the Green Libraries Hubs will support the campaign as it enables climate action in local communities through a network of coordinated library services. ### **Behind the scenes at SCONUL**

SCONUL held a roundtable for library leaders on Friday 23<sup>rd</sup> May to discuss the appetite for, and feasibility of, shared services in the sector. We focussed on the high-level advantages of this approach, both for institutions and the wider sector, and we explored a number of potential opportunities for

collaboration and how we might implement these. Whilst financial savings is a key driver at the moment, other benefits included building resilience, mitigating risk and opportunities for greater innovation. SCONUL will be producing a report with the main points from the day in the next month. SCONUL's Technology and Markets Group will also be undertaking a workshop to scope the feasibility of platform sharing between members.
