Finance survey

SCONUL will shortly be issuing a survey into sector finances. Individual institutional responses will be treated as confidential, but we will use aggregated data to (a) inform negotiations and discussions with publishers and other library suppliers and (b) provide the sector with an overview of the current financial position and libraries' responses to these challenges. This survey builds on the pulse survey carried out in May 2024. The deadline for responses is Monday 20 January. While we appreciate the pressures on everyone's time, a response would be appreciated from as many institutions as possible. This will support the sector as a whole providing intelligence to support negotiations with publishers and for advocacy on behalf of libraries. Directors groups on managing change

SCONUL is setting up a series of directors' groups on managing change. SCONUL Small and Specialist Institutions (SSI) Forum 2025

Lisa McLaren, SCONUL's Deputy Director, outlined the rationale for the upcoming CPD review to the group and garnered feedback around barriers to accessing CPD, including difficulty in releasing frontline staff. The meeting also looked at the Organisational Development Knowledge Base that SCONUL is developing, which aims to bring job descriptions and organisational charts into a shared database. It also looked at the recent mapping work by Ann Rossiter, SCONUL's Executive Director, around rights retention, ILL provision and big deals across the sector and what this might mean for small and specialist institutions. Jisc to take responsibility for HE sector copyright negotiations

Jisc is to take responsibility for the Copyright Negotiating and Advisory Committee's (CNAC) work to negotiate copyright licences on behalf of the higher education (HE) sector. This applies to the four main copyright collective management organisations. For the last 36 years, the CNAC has negotiated copyright licences on behalf of the sector with oversight from Universities UK. It monitors how licences are fulfilled and raises issues with licensing bodies about new products or services that are related to copyright and likely to affect universities. The CNAC also advises Universities UK and GuildHE on UK/EU legislative initiatives and prepares responses to them on their behalf. The CNAC will continue in this role as part of Jisc. Read more

New guide to support authors publishing open access books by Lancaster University Library

Lancaster University Library has launched a <u>new guide</u> to support authors interested in publishing open access books. The guide is freely accessible without registration and it is hoped it will be useful to authors external to Lancaster University who are interested in producing open access longform outputs. The resource covers a wide range of topics related to publishing open access books and includes a range of case studies with authors, detailed guidance on various aspects of the publication process, and useful resources to support users to make informed decisions. It can either be used as a reference guide to find information related to a specific topic, or users can work through each section in turn to help them better understand key considerations when publishing an open access book and to develop their publication strategy. SPARC update - Advancing Rights Retention and Open Licensing across Europe

SPARC Europe leads the Retain Project, which is part of the Knowledge Rights 21 (KR21) programme. They have recently published a position paper on authors' rights, Retaining rights in research outputs to enable the open dissemination of knowledge. This position paper highlights key approaches and challenges that authors, researchers, institutions, and publishers can tackle to facilitate rights retention. To mobilise the ideas and actions outlined in the position paper, they have launched a new webpage, #RetainYourRights, which serves as a call to action for authors, researchers, institutional policymakers and publishers to advance rights retention strategies. You can also sign up to the Rights Retention mailing list to stay informed about the latest resources, events, and advocacy opportunities, all aimed at empowering researchers and institutions to take control of their work and promote open access. Scottish Universities Press now welcoming submissions from all UK HEIs

Scottish Universities Press (SUP), the newly launched open access publisher, has expanded its scope to include submissions from researchers at all UK higher education institutions. SUP is a collaborative initiative supported by a consortium of 19 universities working through <u>SCURL</u>, the Scottish Confederation of University and Research Libraries. The Press initially focussed on books by researchers at SCURL member institutions as part of an incremental start-up plan but has quickly moved to scale up following a successful platform launch in October 2024. New Partnership: The University of Manchester Library and The Dr Williams's Library

The John Rylands Library at The University of Manchester and the Dr Williams's Library have announced a new partnership which will bring together inarguably the two finest collections of non-conformist religious social history in the world and situate them in Manchester, itself a renowned city of dissent and innovation. The new partnership draws upon the almost unlimited scholarly synergies between the existing collections, expertise in the management of special collections, powerful traditions of nonconformity, and a proven track record of impact and public engagement. Following a prolonged period of consideration and with the advice and input of many scholars and researchers, the Dr Williams's Trust was unanimous in its decision to select The University of Manchester Library as the institution best placed to fulfil the Trust's ambition for the future. Online catalogue of New College, Oxford's collection of archives and records launched

New College Library have launched a new online catalogue of New College, Oxford's collection of archives and records—50 years after the publication in 1974 of a summary printed catalogue of our

holdings. Up till now, it has been very difficult for researchers to discover what New College's Archives contain, and so the value and potential of this rich collection have not been fully realised. Over 100,000 historical documents, dating back to the 11th century onwards, were listed in brief format in the printed catalogue, since which time many more documents have been acquired, along with a regular ingress of modern records. The extent and import of the Archives make the collection one of the finest of its kind. Read more
