SCONUL Technology Survey update

Led by the Technology and Markets Strategy Group, SCONUL is developing a survey of our members' use of current and emerging technologies across their library services which will be run biannually. The survey will help SCONUL and its members identify areas of library activity in which there is a lack of competition or poor performance; evaluate potential suppliers; and identify emerging areas of library activity and the existing or emerging technologies being employed to meet these. Last month we undertook beta testing and will be moving to a full pilot later this month. Unsub National Agreement 2023-2026

Jisc will shortly be announcing the new Unsub National Agreement for 2023-26. This Jisc and SCONUL negotiated agreement offers all UK universities, research institutions and affiliate members access to both a local version of the Unsub product and national, consortium level analysis where Jisc is working with the sector to undertake national negotiations. University of Cambridge Rights Retention: Self Archiving Policy

Following a year long pilot, University of Cambridge have formally approved a Self-Archiving Policy incorporating rights retention which will be in effect from 1 April 2023. This policy uses rights retention and automatically covers research students and staff employed directly by the University (with an opt-out available), as well as enabling researchers employed through the Cambridge Colleges to participate on an opt-in basis.
