# Al and the library's role in supporting students, academics and their institutions, 15 and 29 September

SCONUL is holding two linked webinars exploring aspects of the library's role in supporting students, academics and their institutions to navigate the AI revolution. These are community practice webinars, bringing SCONUL members together to share experiences, resources and explore responses to challenges. The first will look at **the support libraries are providing on AI to students in their teaching and in referencing guides** and other guidance. This will be held on Friday 15 September, 11-12.30hrs. The second will look at **the library's role in providing support and advocacy to their institution on the adoption of AI and its integration in teaching and academic practice**. ## The future of the systems librarian webinar, 31 October 2pm

SCONUL has announced the launch of a new project: the Future of the Systems Librarian, which will open with a scoping webinar which will be held on 31 October from 14.00 to 15.30hrs. With developments in library technology accelerating, this project will look at the role of the systems librarian in supporting the evolving needs of the library. Some institutions in the sector are reporting difficulties in recruitment, and succession planning remains challenging as staff in systems roles retire, while the role, and the systems themselves, continue to evolve. As data and learning analytics increase in importance to universities, how can systems librarians provide that added value to their institutions? The project team will take the learning from this community webinar to shape the development of the project. SCONUL has also provided additional analysis alongside its 2021-22 Annual Statistical Data entitled 'Spotlight: first glimpse of the post-Covid library' (2023). This report looks at the last few years and how the HE sector has been forced to adapt to the ever-changing restrictions imposed as a result of the Covid-19 pandemic. It revisits some of the topics included over the last two years and will examine how academic libraries, and their users, have responded to the relaxing of restrictions.

#### RLUK's response to the decision of Dubai as the venue for IFLA WLIC 2024

RLUK has joined other national and international library organisations including <u>SCONUL</u> and <u>CILIP</u> in expressing its disappointment at the decision to select Dubai as the venue for the IFLA World Library and Information Congress 2024. RLUK encourages IFLA to reflect and reconsider this decision, to hear the range of voices from its associations and the wider library community and to act in reaffirming its commitment to promote and value diversity and inclusion. Jisc and OCLC will not be entering into a metadata agreement on behalf of the sector for the academic year 2023/2024. The Transitional National Metadata Agreement between Jisc and OCLC expired in July 2022, and both were unable to agree terms for an extension for August 2022 - July 2023. ## **Podcasts on Artificial Intelligence and the humanities**

The Jisc podcast mini-series *Is AI for me? #### **Exploring Technostress and Al Anxiety among Academic Library Professionals in England**

A study to investigate the prevalence of technostress and artificial intelligence (AI) anxiety among academic library professionals in England is being conducted by Lodovica Corvi, a postgraduate student in MA Library and Information Management at Manchester Metropolitan University. It will examine possible relations of demographics and variables with these phenomena, and identify potential interventions to address and alleviate technostress and AI anxiety within this specific professional context. ### **Copyright Anxiety Study**

Professionals in the UK higher education sector are being invited to complete a survey into levels of copyright anxiety. The Copyright Anxiety Study is a collaboration between the Bodleian Libraries, University of Oxford, City, University of London and the University of Alberta. The research project will be taking place from spring 2023 until early 2024. The aim of this project is to explore levels of copyright anxiety across the UK and Canadian higher education sector, and determine the extent to which copyright law 'chills' innovative research and teaching practice. The research will compare UK responses with those in Canada to investigate the extent to which legal and cultural differences impact on copyright anxiety as a phenomenon.
